# International Congress in Brazil - From July 19<sup>th</sup> to July 22<sup>nd</sup> 2011 -University of Sao Paulo

A great success was the international Congress held at the University of Sao Paulo, Brazil, from July 19 to July 22 2011. This Congress was under the coordination of the Brazilian Association of Vocational Guidance (ABOP) and was held in commemoration of the III Latin American Congress of Counseling, X Brazilian Symposium of vocational guidance and the I Simposium of Research in Career Guidance.

In addition to the participation of more than 400 people, the quality of the papers and round tables carried out, were of very high quality which allowed the reflection by participants on some of the topics which at this time are of vital importance in the field of guidance.

As international guests included the participation of Dr. Jean Guichard (France), Dr. María Eduarda Duarte (Portugal) and Dr. Julio González (Vicepresident of the IAEVG).

In her lecture Dr. Duarte showed that we must make great efforts to unlearn that we are used to learn in the traditional way, in this case we must uncover our ideas to build new ones, and in the case of the guidance it should be considered as a personal process and called to eliminate the traditional points of guidance. In addition, said the speaker, that in the guidance field we should create new models taking into account our reality and emphasized that the guidance is aimed at the construction of ourselves and bring around the idea of team work.

At the opening meeting, celebrated on July 20<sup>th</sup>. the main speaker, Dr. Jean Guichard (France) remarked the following:

- 1) The purpose of the vocational-professional guidance is designed to develop a career and design a project of life in general.
- (2) Each individual is entirely responsible to build her/his own life and career.
- (3) Counseling has among its functions: to) develop vital skills that enable the self-construction of life. The skills to develop in this case should respond to the questions of how do? With who and why? In his point of view, this last skill was not yet considered by the counselors.
- (b) Preparing individuals to perform at the "liquid society", bounded by Bauman and the "society of the individuals", suggested by Norbert Elias. (c) Develop a process of customization in the quidance users.

We recommend reading the book Psychology of Guidance and Counseling Designing Life of the author. d) Within the counseling process should consider social factors (which are visible), and psychological factors (which are intangible).

Dr. Julio González raised some of the main challenges of the Counseling in the new social scenarios that Latin America has to do with:

- a) Redefinition of the professional field and its theoretical model.
- b) Training professionals of the Guidance,

- c) Preparation in the new skills,
- d) Consolidation of professional identity (through the consolidation of statehood policy guidance)
- e) Development of new proposals for approaches,
- f) Implementation plans integrators in Guidance, and
- g) Integration between the counselors (through the consolidation of the Latin American Network of Guidance Professionals and national associations).

Towards Quality and Professionalism in the German Career Guidance System – Presentation of Common Quality Criteria, a Quality Development Framework and a Competence Profile for Guidance Practitioners

The Project "Open Process of Coordination for Quality Development" launched its results at the conference "Perspectives of good guidance – developing quality and professionalism in career guidance", 19<sup>th</sup> January 2012 in Berlin

After more than two years of intensive cooperation and coordination work with experts and stakeholders from policy, science, practice and the social partners a system of quality criteria und indicators, a competence profile for guidance practitioners, and Development Framework (QDF) for guidance providers were presented to a broader audience of career professionals, guidance providers and policy makers. The aim of the project, which was carried out by a research unit at Heidelberg University under the leadership of IAEVG member Professor Christiane Schiersmann and by the German National Guidance Forum (nfb) and which was funded by the Federal Ministry of Education and Research, is the implementation of commonly agreed standards for quality and professionalism in career guidance in Germany.

Key note speaker Prof. Anthony G. Watts (UK) placed the German quality process in an international context of quality development in career guidance. Discussions in the conference forums and in a high level policy panel signalized broad acceptance of the results and a need for commonly agreed quality standards. Further questions centered on the policy implications of implementing binding quality standards.

With the validation of the results at the conference the second project phase now emphasizes implementation strategies and the evaluation of the outcomes and impact of the quality development process. Another focus will

be the development of competence assessment instruments for career guidance competences. The QDF and the quality criteria will further be piloted within a broader scope.

many as 60 Universities, the Society has promoted the setting up of the *Network – University Training in Vocational Guidance*, which has already established two post-graduate inter-University Courses with the aim of



enhancing the training of our young counsellors and practitioners.

In addition to being strongly active as regards the consolidation and the development of its membership, the S.I.O is currently very much engaged in the certification of competencies of career professionals.

At a time when improbable privatistic lists or repertories devoid of any scientific legitimation seem to continually spring up, the S.I.O. believes it has become unavoidable to act in order to safeguard clients, customers and career professionals themselves. The Society has decided to offer on a voluntary basis, initially only to its members, the opportunity to have one's own vocational guidance competencies certified. This is based on a deeply discussed and talked-over repertory that has been devised also in relation to prospects of professional training/updating.

It is a far-reaching commitment indeed, which the S.I.O. considers absolutely essential, above all in order to develop and maintain a high scientific and professional profile in the vocational guidance field. This is especially important nowadays in light of our country's difficult economic situation, which inevitably has a strong impact also on people's choices and personal development.

#### Erasmus NICE Network to publish handbook on developing degree programs in guidance

The "Network for Innovation in Career Guidance & Counselling in Europe" (Erasmus NICE Network) is currently working on a handbook for

setting up and developing academic degree programs in career guidance & counselling.

Through the "Handbook for Tuning Degree Programs in Career Guidance and Counselling", the Erasmus NICE Network aims at reaching several goals: On the one hand, the handbook shall provide a tool for setting up new study programs, on the other hand it is supposed to promote the development of mature degree programs, e.g. in terms of quality management, contents or methods of teaching/learning. Through the improvement of higher education in career guidance & counseling, the handbook shall contribute to realizing the vision of providing lifelong high-quality services in career guidance & counselling to everyone all over Europe.

The Erasmus NICE Network involved 40 academic institutions who either offer degree programs or who conduct research in the field of career guidance & counseling. From 2009-2012 the network, which is coordinated through the Heidelberg University, is being funded by the European Commission.

The handbook will be published in fall/autumn of 2012 and will be available both in hard copy and for download through the homepage of the Erasmus NICE Network: www.nice-network.eu.
