## **Campaign Purpose - A Permanent Home**

The Ohio Association of Elementary School Administrators has operated out of leased facilities since its inception. Given the Association's growth during the past few years and success in solidifying a financial position, the OAESA Board of Directors felt it was time to invest in the future. By obtaining permanent headquarters, OAESA was able to select a building that lent itself to operations, programs, special projects, and future growth. OAESA's new home also gives the Association more control over daily operating expenses.

OAESA's mission of serving educational leaders, children, families, and communities across Ohio will continue throughout perpetuity. Please consider leaving a legacy of leadership for those who will be involved with OAESA and FACE in the future.



## **Why a Capital Campaign**

The OAESA Board of Directors feels it is extremely important to position the organization for the future so it can continue its role of supporting and serving the education community. OAESA's permanent headquarters is a key element in this posturing.

A capital campaign will provide ongoing funds which will be used to offset the cost of securing the building and will provide an opportunity for early debt reduction. Raising funds through a capital campaign will assist in OAESA's continued commitment to members without compromising the quality and quantity of offerings.

We invite you to support the mission of this campaign. By participating, you will help affirm the principal's role in leading learning communities and confirm the importance of curricular-enhancing programs for Ohio's students.

## **Campaign Goal**

Through the capital campaign, we seek to raise \$250,000 to \$500,000 over the next three years. OAESA's new headquarters is located at 900 Club Drive in Westerville and is valued at \$1.2 million. With contents, it has a total net worth of \$1.5 million. OAESA maintains equity of \$250,000. The building is 11,000 square feet, with OAESA/FACE occupying 7,000 square feet. The remaining square footage is currently leased to two tenants on long term leases.
