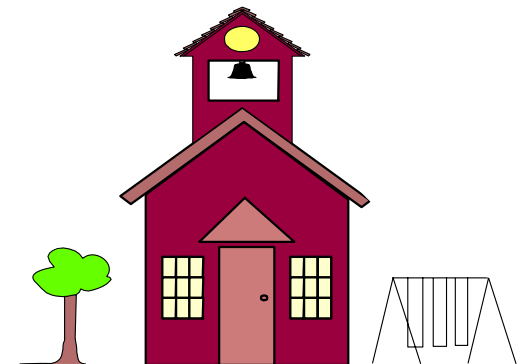

Proposal

Exemplary educational programs meeting the needs of students in both elementary and middle schools across the state are significant by their existence. Continued exemplary performance is encouraged by recognizing the administrators and staff who conduct these programs.

Nominations – Step 1

(form attached)

Any administrator, teacher, student, staff, or citizens' group that feels a particular elementary or middle school exemplifies quality education may nominate that school for consideration. Information received by the Hall of Fame Committee will be considered confidential.

All nominations must be received no later than December 15, 2009.

Special Requirements

- The principal of the nominated school must be a member in good standing of OAESA.
- The principal of the nominated school/building must have been the principal at the nominated building the previous year.
- The nominated school must have an acceptable status with the Ohio Department of Education (i.e. not in academic emergency or academic watch).
- Hall of Fame school recipient may not apply again for a three-year period.

Application – Step 2

Once a nomination form is received, OAESA will send an application to the principal of each nominated school so they can begin the process of completing the application narrative. The application must be completed in its entirety and returned to the OAESA office postmarked no later than January 15, 2010.

Application Format



The materials presented must be in the same form as the application. Each criterion must be addressed. An electronic version of the application will be made available; however, the completed application needs to be submitted by US mail.

The application must be postmarked by January 15, 2010.

Selection Procedures – Step 3

The Hall of Fame Committee will review all applications to determine that the basic criteria have been met. The top two schools in each zone that meet or exceed the stated qualification score will be scheduled for an on-site visitation by practicing principals from OAESA's Hall of Fame Visitation Committee.

Awards

 The winner will be honored at the  annual OAESA Professional Conference Awards Luncheon held during the OAESA Professional Conference on June 22, 2010. Recipients of this award will be offered the opportunity to make a ten minute presentation at the OAESA Professional Conference. Hall of Fame plaques will be presented to the principals of the selected exemplary schools.
