



You are cordially invited to participate as an exhibitor at the Ohio Osteopathic Symposium, a collaborative program sponsored by the Ohio Osteopathic Foundation and the Ohio University College of Osteopathic Medicine (OU-COM). This event replaces the Ohio Osteopathic Convention, typically held in June, and the OU-COM CME & All Class Reunion which is typically held in September.

This year's program will be held Thursday, April 29 – Sunday, May 2, 2010 at the Hilton Columbus at Easton in Columbus, OH.

It is anticipated that approximately 300 physicians from across Ohio and neighboring states will attend the 2010 Ohio Osteopathic Symposium. This event is the state's largest CME program for osteopathic physicians. The educational program will offer more than 25 hours of AOA Category 1-A CME credits, as well as the opportunity for physicians to meet with representatives from companies whose products and services enhance the practice of medicine.
