She is well respected by her physician colleagues who elected her to serve as President of the Arizona Academy of Family Physicians. She was the Chairperson for the Subcommittee on Women of the 93,000-member American Academy of Family Physicians (AAFP) and was elected to serve in the AAFP Congress of Delegates, the policy forming body of the organization for eight years. She is Past Chair of the Americans in Motion Advisory Panel and the AAFP Women's Health and Physician Wellness Conference. She served on the AAFP Commission on the Health of the Public and the American Medical Association's Healthy Lifestyles' Advisory Panel.

JAMES O. WATSON, DO dedicated his life to the osteopathic profession for more than four decades before his death in 1985. A graduate of the Kirksville College of Osteopathic Medicine, he helped found Doctors Hospital North and served as chief of surgery there from 1940-1963. He was the first osteopathic physician to be appointed to the Ohio State Medical Board where he served for a total of thirty-two years. In 1972, he was named honorary president of the Ohio Osteopathic Association – the first and only such award ever bestowed – and the J.O. Watson Memorial Lecture was established to honor his ideals and example.

Dr. Licciardone is Executive Director and Osteopathic Heritage Clinical Research Chair at The Osteopathic Research Center located at the University of North Texas Health Science Center – Texas College of Osteopathic Medicine. He also serves as Associate Dean for Clinical Research at the Texas College of Osteopathic Medicine and holds the Richards-Cohen Distinguished Chair in Clinical Research.

He is the first osteopathic physician to have received a Midcareer Investigator Award from the National Institutes of Health. He serves as Principal Investigator for the OSTEOPATHIC Trial, an ongoing five-year study that seeks to recruit about 500 subjects to evaluate the efficacy of osteopathic manipulative treatment. His previous research forms the basis for the American Osteopathic Association Guidelines on Osteopathic Manipulative Treatment for Patients with Low Back Pain, which were recently accepted by the Agency for Healthcare Research and Quality for posting on its National Guideline Clearinghouse.

**J.O. WATSON, DO ENDOWED DIABETES RESEARCH CHAIR
OHIO UNIVERSITY COLLEGE OF OSTEOPATHIC MEDICINE**

The J.O. Watson, DO Endowed Diabetes Research Chair was established at the Ohio University College of Osteopathic Medicine in 2001. Endowed by the Osteopathic Heritage Foundation, the chair was created to advance research into rural health management of diabetes and cardiovascular disease.

In 2009, Dr. Schwartz, professor of endocrinology in the department of specialty medicine at the Ohio University College of Osteopathic Medicine was named James O. Watson, DO Endowed Diabetes Research Chair. His work ranges from research into the treatment potential of newly discovered compound C-10 for diabetes and other diseases, to various clinical studies on community health trends and endocrine disease management. He is currently working to improve medical technology for diabetic patients by co-developing an artificial intelligence software program for insulin pumps for type 1 diabetes patients. The software interprets how lifestyle trends impact individual patients' glucose levels and offers evidence-based solutions to problems.
